Moreover we are looking forward to empanel other for our other business verticals like Grocery, Textiles, General Merchandise (supply of stationery, FMCG products etc to Gov. departments).

**Minimum Credentials:** The organization should furnish Partnership Deed/ Registration Certificate, Certificate of Incorporation, Articles of Association, Memorandum of Association as applicable for respective vendors, financial statements of at least last three financial years, profile of key staff, possession of certain business licenses(if applicable), Work completion/experience certificate and other provisions of eligibility as laid down in our Business Guidelines under the head registration of suppliers/vendor. NCCF, Ahmedabad would empanel you based on the scrutiny of your documents, inspection, and other mentioned eligibility requirements and other norms incorporated by our Headquarter from time to time. Firms shall not be blacklisted or has been found guilty of misconduct in professional capacity by GOI/State Gov/CPSEs/SPSEs/Statutory bodies/other government department. The suppliers/vendors must be registered with GST, IT & statutory registrations (as applicable). The terms and conditions for vendor may be amended from time to time and the same will be binding to the vendor/supplier. Firms whose near relatives are working in NCCF will not be considered for empanelment.

**Empanelment Period:** The Co-op/company/prop.etc shall be empaneled for a period of one year, initially. However, a review exercise may be made periodically based on performance along with necessary information. NCCF, Ahmedabad reserves its right to de-list the name of the empanelled co-op soc./supplier at any stage, if found unsatisfactory or does not comply with the NCCF's requirement.
