It was registered in October, 1965 and is functioning under the Multi-State Cooperative Societies Act, 2002. As on date, NCCF has 152 members, which includes the Government of India, three national level cooperative organization, namely the National Cooperative Union of India (NCUI), Nation Cooperative Development Corporation(NCDC) and the National Agriculture Cooperative Marketing Federation of India (NAFED).
